THE ENERGY SECTOR WILL GATHER AT THE 15TH TÜRKİYE ENERGY SUMMIT

The Türkiye Energy Summit, which has become a tradition as the “Biggest Family Meeting” of the Turkish energy industry, will be held for the 15th time this year on December 8–9, 2025, at the Hilton Istanbul Bomonti Hotel Conference Center.

As the first and only event that brings together the electricity, natural gas, fuel, LPG, and sustainable energy markets, the Türkiye Energy Summit is organized this year by Enerji Fuarçılık under the theme: **“QUO VADIS ENERGY INDUSTRY?”** The Summit will host comprehensive sessions addressing opportunities and risks for the future of the energy sector in the context of geopolitical tensions, technological breakthroughs, market fluctuations, and changing policy environments in the global energy transition.

As every year, the Türkiye Energy Summit will bring together more than 1,500 domestic and international participants, along with public and private sector representatives from Türkiye and neighboring countries. The Summit will open the door to new collaborations shaping the future of the sector and contribute to sharing strategic ideas and producing sustainable solutions in line with the development and transformation of energy markets.

The Summit Will Address Critical Topics for the Energy Sector

At this year’s Türkiye Energy Summit, critical topics that will determine the future of the sector—such as energy efficiency, LNG markets, green energy and carbon regulations, storage technologies, international investment opportunities, digitalization, and the transformation of mobility—will be examined in dedicated sessions. Participants will discuss opportunities and challenges in Türkiye and regional energy markets during sessions featuring insights and experiences shared by international experts and industry leaders.

Global Experts Will Discuss the Future of Energy in Istanbul

This year’s Türkiye Energy Summit will host special sessions addressing energy transition from an international perspective. At the **Mediterranean Session**, Hasan Özkoç, Director of the Mediterranean Energy Regulators Association (MEDREG), along with representatives from regulatory authorities of member countries, will evaluate regional energy transition, integration steps, and the role of regulatory authorities.

The **LNG Session**, which holds a significant place on the global energy agenda, will be moderated by Sohbet Karbuz, Director of OME Hydrocarbons. With the participation of Gergely Molnar from the International Energy Agency (IEA) and energy law expert Attorney Ana Stanić, the future of LNG markets, the impact of geopolitical developments, and energy security will be discussed.

Additionally, in **the Green Energy and Carbon Regulations Sessions covering Europe and Türkiye**, representatives from the Zero Emissions Trade Association (ZETA), the Romanian Energy Traders Association, the Clean Energy Consumers Association, and the Ministry of Environment, Urbanization, and Climate Change of Türkiye will participate. These sessions will examine energy transition goals, carbon trading systems, and green transformation strategies from both European and Turkish perspectives.

The Summit will also explore investment opportunities in the energy sector in light of global economic and geopolitical developments. During the **International Investment Opportunities for the Turkish Energy Sector session**, companies' strategies for growth and diversification in new markets will be discussed alongside the increasing investment interest in the Turkish energy sector, aiming to contribute to the sustainable development of the industry.
